ELIZABETHTOWN HERITAGE COUNCIL

FEEDING AMERICA, KENTUCKY'S HEARTLAND FUND

Imagine one day without food. Now imagine day after day without food. It's hard to fathom not having enough to eat or to feed your children. Unfortunately, that is the reality for some families in our region.



Feeding America, Kentucky's Heartland envisions a community where no one will go to bed hungry. They live out its mission by acquiring and distributing donated food and grocery items across our region.

In 2016, Feeding America, Kentucky's Heartland setup an Endowment Fund through CKCF, securing a future where it can forever help feed those in need in our community.

"Realizing the importance of sustainable and reliable funding for a nonprofit like ours, Feeding America, Kentucky's Heartland has partnered with CKCF to begin an endowment fund," said Gary Miles, Executive Director of Feeding America, Kentucky's Heartland. "Though fairly small now, we hope the principal and subsequent income generated from this fund will begin to grow and help us expand our ability to better feed hungry Kentuckians throughout our 42-county service area."

Nonprofit Endowment Funds generate consistent investment income and ensure the future of their work will continue to give life.

Gifts to these funds may also be eligible for the Endow Kentucky state income tax credit which offers donors up to a 20 percent credit for their contribution.

ELIZABETHTOWN POLICE FOUNDATION

In 2014, the Elizabethtown Police Foundation was getting started, and CKCF was there to help them get off the ground, serving as the fiscal sponsor until EPF became established. Now EPF is a successful foundation that assists officers, staff and their families in times of crisis as well as provides much-needed resources, like their drug dog Canine Lola.



FRUGAL MEALS

Nineteen families in central Kentucky gave life to the philanthropic mission Frugal Meals. These families opened their homes to host modest dinners for friends and family between Ash Wednesday and Easter Sunday to raise money and awareness for 15 nonprofit organizations in our area. Through the Frugal Meals initiative, over \$9,000 was raised by those hosting simple dinners in their homes.

Philanthropy Gives Life to Women's Initiatives



Heels Together is changing the lives of women and girls in Hardin County, forever. Heels Together grants build programs and shape the future for females in our community. These programs provide skills and knowledge needed to become self-sufficient, encouragement for girls to pursue nontraditional career fields, as well as resources and healing aids for victims of violence, abuse and neglect.



Why does Heels Together work so hard to give life to initiatives for women and girls? Heels Together investor Christy Pritchard says it best, "When 51% of your population is not given the tools to feel empowered to succeed, the whole community suffers. THAT should matter to everyone."



One Heels Together grant is getting girls excited for careers in nontraditional fields like science and technology. The 2017 Shattered Glass Summit gave 75 girls, in 4th through 6th grades the opportunity to explore STEM fields with hands-on experience flying drones and programming robots. Grant recipient, Hardin County Schools brought this program to life and opened it to girls throughout the community.

HEELS ACADEMY GIVES LIFE TO LOCAL WOMEN'S DREAMS

Abigail Sperko was a young mother raising two little boys alone after the untimely and tragic death of her fiancé. No longer having support from her fiancé, she moved in with her father. She was not working, not sure where her future would lead and was dealing with much sadness and grief. She was struggling to keep afloat and depended solely on her father for her day to day necessities.

During a visit to Clarity Solutions, Abigail shared with her mentor that she was struggling to get back on her feet. She dreamed of becoming a nurse and providing a better life for her children. However, she had no idea where to start or if it was even possible. Her mentor at Clarity heard her concerns and put her in contact with Heels Academy, a 6-month program designed to help women become self-sufficient.

Heels Academy is comprised of several agencies that work together to provide women with life skills to cope with everyday challenges. The workshops cover topics such as leadership and commitment, job readiness, financial literacy and healthy relationships.

Abigail graduated from Heels Academy in 2017. By the end of the program, she turned her life around. She enrolled in the work-study program at ECTC and completed her first year of classes in December 2017. She is currently employed as an assistant in the nursing department.

For Abigail, one of the most important workshops of Heels Academy was the financial literacy class. With better budgeting skills, she was able to secure an apartment for her family that they can now call their home. Through the program, she was also connected to assistance with daycare while she works.

"I had no idea I would be able to accomplish so much in such a short time," said Abigail. "The coaches at Heels Academy recognize what I am capable of and believe in me. They are angels on earth, my own fairy godmothers. Without their help, I would not be where I am today."

Her dream of a nursing career is well on its way to becoming a reality, and she is on the road to healing from the loss of her fiancé. She hopes to one day pay it forward and help others like those that make Heels Academy possible. Through tears, Abigail shared, "I wish I could personally thank each person that helped Heels Academy get its start. It has changed our lives forever."

Matthew Moreman graduated from Elizabethtown High School in 2012. He was born and raised in Hardin County, and as a young high school student, he was excited about the possibility of moving off to college. When he was accepted to the University of Kentucky, he could not have been more excited.

Matthew's excitement continued when the Elizabethtown High School Class of '66 awarded him with their scholarship. With this scholarship and a few others, Matthew had his first year of college tuition covered.

During his sophomore year, Matthew accepted a co-op position with Altec Industries in Elizabethtown. In May of 2017, Matthew graduated Summa Cum Laude from UK with a degree in Mechanical Engineering. After graduation, he was offered a full-time position at Altec as an Application Engineer.

"This scholarship, along with a couple of others I was awarded, helped me to adjust to college life. I was able

to focus on my classes and grades the first year, instead of worrying about my finances," said Matthew. "Being awarded a local scholarship also gave me even more of an appreciation for our community. Having local people care that you succeed, made me honored to come back to Hardin County to work."

When the Elizabethtown Class of '66 came together at their 30th reunion, they reflected on how instrumental EHS had been in their individual successes. They decided to honor the school by establishing a scholarship for future graduates of Elizabethtown High School. The endowed scholarship supports awarding a \$1,000 scholarship annually. Scholarships give life to opportunities for students just like Matthew. They are stepping stones on a student's path to success. \$1.6 MILLION GIFT CREATES NEW SCHOLARSHIP OPPORTUNITIES FOR LaRUE COUNTY STUDENTS

The legacy of Harold and Cynthia Carter will go on forever through the many students who will benefit from their generosity.

Through their estate, the Carters' \$1.6 million gift, thought to be the largest single charitable gift in LaRue County history, is a true community asset for LaRue Countians.

As an endowment fund of CKCF, the Harold and Cynthia Carter Scholarship Fund will make awards yearly. Beginning in the fall of 2018, up to 10 students will receive a \$2,000 per year scholarship to attend Elizabethtown Community and Technical College.

A distinguishing feature of the Carter's scholarship fund is that it is open to past and current year graduates of LaRue County High School. Mrs. Carter attended college later in life and valued the importance of supporting education and opportunities for improvement throughout life. This generous gesture opens the scholarship to many

more residents of LaRue County.

"It was an honor to work with Mrs. Carter as she considered ways she could invest in education," said Davette B. Swiney, President and CEO of CKCF. "The passion in her voice was evident. It was a very personal commitment and decision to make this significant gift to help students."

YOUTH SPORTS FUND OF HARDIN COUNTY

As a child growing up in Hardin County, Lindsey Keith Alicna, Fund supporter, credits sports for motivating her to self-improve, learn healthy habits and above all, provide some of her fondest memories.

These experiences are why the Youth Sports Fund of Hardin County was created. The fund makes recreational sports open to families who may not be able to afford the expense. Recreational sports allow athletes to grow and develop beyond what they learn in a classroom or at home. Sports introduce children to a healthy, active lifestyle and teach good sportsmanship and teamwork. It also helps children develop their cognitive and physical skills and contributes to higher levels of self-esteem and self-worth. Joining a sports league is an opportunity that all children should have access to in our community, and the Youth Sports Fund helps makes it possible.

"We are all better served by a community that is able to offer youth sports to anyone that wants to participate. There should be no limitations to participation for those who may not be able to afford the equipment or participation fees," said Alicna. "Sports have proven to be a catalyst to producing better citizens and members of our community; we should do everything in our power to make that available to any child that wants to play. I think we will see the fruits of this throughout those athletes' lives."

This fund provides financial support for children interested in youth recreational sports in Hardin County. Grants made from the Youth Sports Fund will assist children with

registration fees and equipment, allowing even more young people in the community access to sports.

For over 45 years, the Washington County Association for the Mentally Handicapped supported the needs of the intellectually disabled in Washington County, Kentucky.

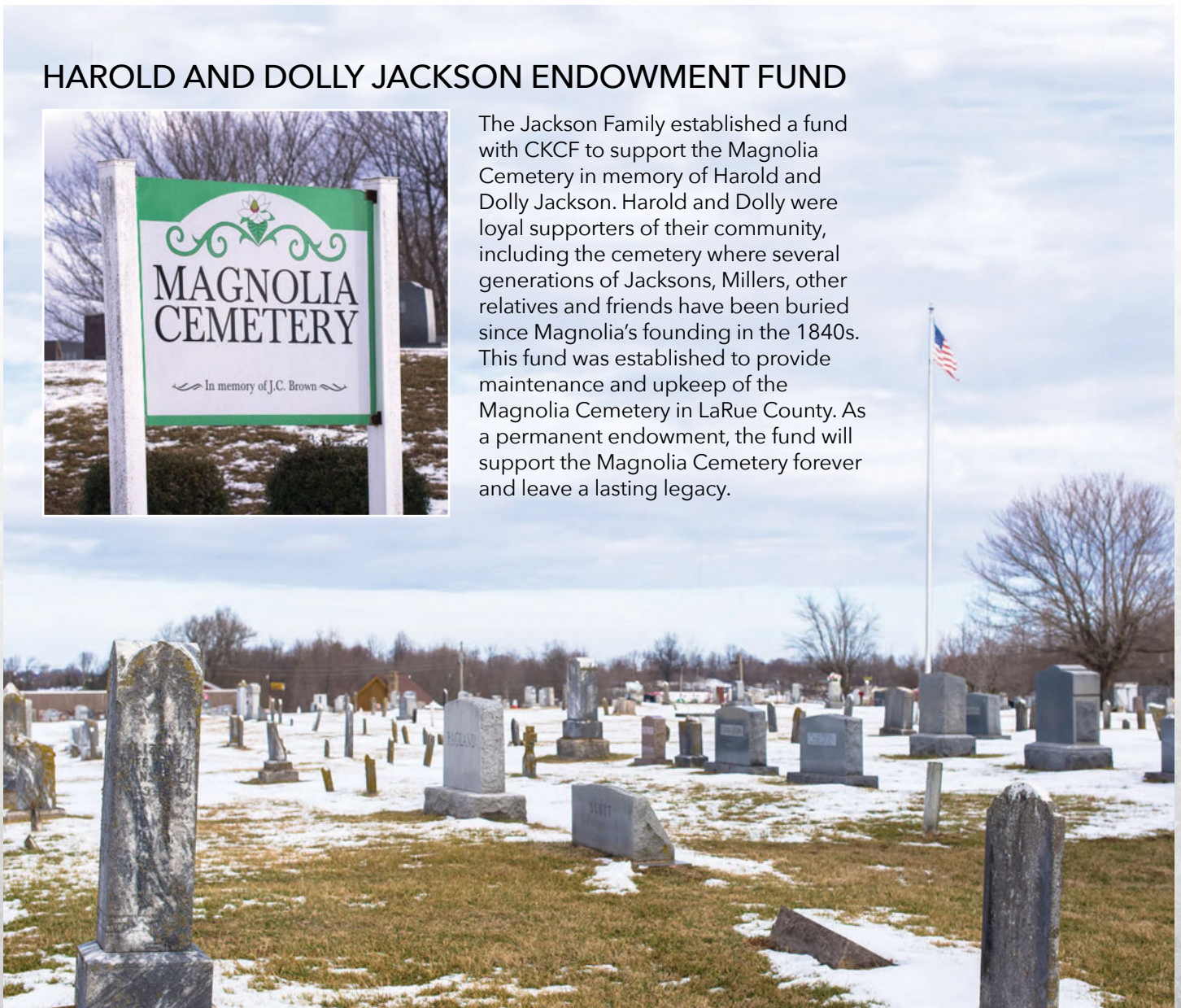
