Central Kentucky Community Foundation was proud to partner with the association and help make this important project a reality.

"We needed a partner to get this going, and the community foundation was that partner," said Matt Deneen, who led the project.

Like many organizations, the paddlers association does not have 501c3 nonprofit status, meaning donations to the organization are not tax deductible. Obtaining taxexempt status can take more than a year and there are costs involved.

Paddlers with a Purpose had an opportunity to accept a significant gift, but the donation needed to be tax deductible. That's where the

"When presented with a great idea, our community is generous and will step up to make it happen," said CKCF President and CEO Davette B. Swiney. ### Scholarships help students pursue academic goals

Through the generosity of many donors and CKCF, many students in the region will have fewer college financial worries.

"Our community continues to demonstrate a belief in our youth and educational opportunities for them through scholarships," said Davette B. Swiney, President/CEO. "We are honored to work with people to personalize the scholarships and make them available to students through an online portal, Scholarship Central." This year, **63 students** from

13 schools received

totaling \$100,000 from CKCF. Additionally, 30 upperclass

students were eligible to renew previously awarded scholarships for continuing financial support.

The dock was dedicated to Bob Wade Sr., who was a Korean War veteran, and his wife Ella Mae Wade, who, standing with Deneen, Swiney and Elizabethtown Mayor Edna Berger, snipped the ceremonial ribbon.

As paddlers and supporters took in the new attraction and cheered for a demonstration by a wheelchair user, the scene was a source of pride for our community.

"It goes beyond veterans. It goes beyond civic organizations. It goes beyond corporate partnerships," Deneen said. "It's amazing what can be accomplished when we all pull together."
