Dow Company Foundation invests in the community through sustainability grant

A \$425,000 sustainability grant from Dow Company Foundation that includes a community outdoor space, an investment in environmental strategies, and a support space for area nonprofits was created in the spirit of philanthropy. Our community will benefit from Dow's generosity for generations to come.

"This investment into strategic environmental and capacity building initiatives led by Central Kentucky Community Foundation embraces our strong legacy in the region while generating a transformative impact for future generations," said Nick Powell, Site Leader at Dow.

This grant offers a convenient way for the community to engage with their food supply and nature through volunteerism. It will involve the public, nonprofit, and private sectors to grow relationships, collaboration and expertise.

"This is probably one of the most innovative ideas I've come across," said Sean Clinning, Operational Productivity Improvement Leader at Dow. "When you think about sustainability, this project is not just about environmental or recycling sustainability, this is about community sustainability," he added.

The Dow Environmental Sustainability Initiative will be the catalyst for community recycling infrastructure and other environmental efforts. Industrial leaders have created recycling programs such a material swap program to employee recycling incentives and sustainability standards.

"We know waste reduction efforts are challenging and there are no simple answers," said Davette B. Swiney, President and CEO of Central Kentucky Community Foundation. "From reducing to reusing to recycling, there are ways we can make a difference in our community. We can work together – philanthropy, the public sector and each one of us as individuals to be effective."

The Community Hall in CKCF's Home of Philanthropy supports nonprofit work and community initiatives to help bring life to new ideas by offering a place for nonprofits to convene, collaborate and host meetings, in-person or virtually. This investment displays Dow's longstanding commitment to the community and investment in nonprofit work.

"Whether you work at Dow, partner with us, or experience our materials in your favorite brands, we are relentlessly working to make the world and this community a better place to live and work. By listening and collaborating, we can find out what solutions will help us achieve these results," said Nancy McCoy, Quality Manager at Dow.

The Dow Sustainability Grant is just the catalyst. The success of these programs will be accomplished through collaborative efforts from the community. Everyone in the community has something to contribute.

"This is a community project. We are just honored to be the convenor and collaborator to bring these initiatives to life," said Swiney. 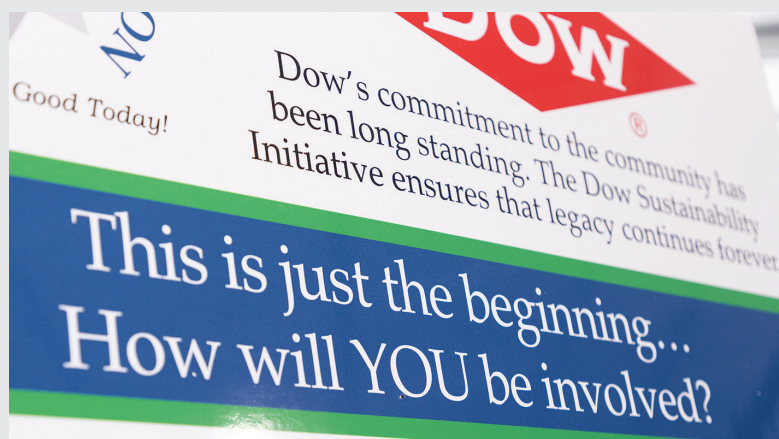

Granted Program makes significant impact in first year

Central Kentucky Community Foundation launched a new competitive grant program in 2021. Nonprofit organizations submitted applications for up to \$5,000 in three categories: capacity building, capital improvement and programming.

"Part of our work as a community foundation is to connect the generous people in our region with the ideas, opportunities and needs to enhance our region," said Davette B. Swiney, President & CEO.

This funding opportunity provides a grant structure that connects these resources to nonprofits, helping them carry out their mission. CKCF has awarded grants from funds for their specific purposes for many years. Now Granted provides nonprofits with a recurring opportunity to try new initiatives, respond to current needs, or build their organization.

The first year of Granted culminated in November when CKCF awarded \$76,439 in grants to 14 nonprofits.

"Through the generosity of our donors, along with the foresight many years ago of people who gave to this community in a long-term and thoughtful way, we have the opportunity each year to make

grant awards in relevant ways to impact our community today," said Swiney, "CKCF's funding of these grants comes from our unrestricted grantmaking fund, which gives us the flexibility to meet ever-changing community needs."

Two grants were awarded for capacity building. **The Lincoln Museum** received funding to upgrade their technology capabilities and **Helping Hand of Hope's** grant will equip them to go directly into neighbors and serve people where they live.

"The grant funding has had an immediate impact on our collections, research, and cataloguing efforts," said Iris LaRue, Executive Director of the Lincoln Museum. "This additional equipment is being used to document, catalog, and digitize items in our collection as well as provide additional public access

to our collections. The installation of the additional components will further enhance staff productivity as well as broaden the museum's overall digitization and cataloguing efforts."

Three nonprofits were funded for capital improvements. **The Community Health Clinic** purchased lifesaving machines for heart patients, **Project L.E.A.R.N.** has been able to utilize their entire facility with the addition of a new HVAC unit and **Bethany Haven** offers privacy in a shower room at a Room at the Inn location.

"It is imperative to those who are homeless to have a place to go not only for shelter, food and supplies, but also for a hot shower, and a place to do their laundry," said Treasure Davidson, Executive Director of Bethany Haven. "We have been blessed to be able to provide

these things and thanks to Central Kentucky Community Foundation, we now have more options for desperately needed showers.”

Programming grants will help six nonprofits expand their efforts in areas that are core to their mission. Those organizations are **CASA of the Heartland, Crossroads Life Center in Hart County, Grayson County Alliance, Wesley Hilltop House, Big Brothers, Big Sisters of Kentuckiana, and The Salvation Army of Elizabethtown.**

“Money Habitudes--Financial Literacy Series aligns with our mission of teaching life skills and empower family stability,” said Debbie Childress, Executive Director of Grayson County Alliance. This course will teach people the habits and attitudes to help them manage their money better by establishing tools for budgeting and setting family goals. We really want to mentor, encourage, and empower families through this curriculum,” she continued.

Two specific CKCF funds also accepted applications through the Granted process: the Bishop Charitable Fund and The Marvin and Joyce Benjamin Fund.

Silverleaf Sexual Trauma Recovery Services received support for their project focused on helping Washington County residents in poverty develop individualized self-sufficiency plans to overcome barriers. **Feeding America, Kentucky’s Heartland** received funding enabling them to disperse culturally diverse food into the communities it serves.

“Prevention is key to eradicating any negative outcome,” said Jillian Cardin, Psy.D, Executive Director at Silverleaf Sexual Trauma Recovery Services. “We know that individuals with financial instability are more likely to be abused, misused, mistreated and/

or violated because they must rely on other people to function. This project allows Silverleaf to promote a proactive approach to ending all types of sexual violence by equipping individuals with the tools, and resources to improve their financial stability.”

“We are proud of the significant work our nonprofit community does all year long to make our community a better place,” said Swiney. “The grant awards are just a small, but hopefully, meaningful investment in their work.”

KY Gives Day

Donors from across Kentucky gave to 22 nonprofits during the ninth annual KY Gives Day in 2021. This 24-hour online giving blitz raised \$193,764 for nonprofit organizations in our region. Those

gifts came from 768 donors. The region's generosity was reflected on the state leaderboard, with four of the top 10 fundraisers were local organizations.

"We are overwhelmed and humbled by the response to our KY Gives Day fundraiser

this year," said Jennifer Moran, Director of Mission Advancement for Saint James Catholic School. "The fact that we were able to exceed our goal is a testament to the Saint James Catholic School and Church family who rallied around our campaign. Our students will be the ones to benefit from the funds raised as we expand the services we have to offer. With additional Academic, Social/Emotional Support as well as Occupational and Speech Therapy, we will be able to provide our students with the services necessary for individual success. We are so grateful to CKCF for being so gracious in offering support for KY Gives Day – they are a big part of our success."

Endow Kentucky:

A legacy to support efforts most important to you

Endowed gifts can provide personal fulfillment and also have the added benefit of a tax credit through the Endow Kentucky program.

The Endow Kentucky tax credit is available to any Kentucky taxpayer, business or individual, to receive a state tax credit up to 20% of their charitable gift to a permanent endowment at Central Kentucky Community Foundation.

"There are multiple benefits to using the Endow Kentucky Tax Credit," said Cliff Fowler CPA/PFS. "First, there can be significant tax savings for the donor. Second, the fund will keep up with inflation. It will continue to have today's dollar value rather than the initial contribution. In other words, the fund distributions increase every year."

Endowment Funds provide annual support for a nonprofit organization* in perpetuity.

"An endowment gift is great for a person with a charitable heart who wants their gift to have a lasting impact; not just an immediate one-time impact," Fowler said. "You don't have to invest major dollars to take advantage of the tax

credit. The best part is that you can choose where the money goes," he added.

The tax benefit is not just for cash gifts. Noncash gifts such as securities and real estate gifts can qualify too.

"Donors who have appreciated stocks, mutual funds or real estate can transfer those assets to an endowment fund to avoid taxes on the gain, receive the tax credit and avoid taxes on the appreciation," Fowler commented.

When considering starting an endowment fund or adding to an existing one, the Endow Kentucky tax credit process is simple and credits are available each year. Only certified community foundations, like CKCF, are qualified to offer this tax credit.

"When using CKCF for endowment fund management, you have peace of mind knowing the money will always go where you intended.

CKCF will take care of your gift, honoring their promise to fulfill your charitable intent forever," said Fowler.

Endowment giving is a way your legacy can extend in perpetuity through charitable giving
