People were satisfied, but not impacted.


We did the best we could.

# Central Kentucky Community Foundation Announces \$10,000 Endowed Gift for the Dolly Parton Imagination Library

An anonymous \$10,000 donation has been given to start an endowment to support the Dolly Parton Imagination Library Program in Hardin County in partnership with CKCF. This announcement came during CKCF's 10th anniversary celebration of *Get Ready! Camp* in June.

"We have been working on continued funding for the Dolly Parton Imagination Library for the past year," said Nancy Shores, president of Friends of Hardin County Public Library. "This endowment fund with CKCF will help ensure the program will continue for years to come."

Camp* in 2012 and it has expanded since inception. This free summer camp provides a unique learning experience for children from birth to age 5 and parents to discover how they can easily learn through play.
