IRA Charitable Rollover

If you are 70 ½ years old or older with an individual retirement account (IRA) you are now allowed to make a qualified charitable distribution from your IRA directly to a qualifying charity, such as a fund at Central Kentucky Community Foundation, *without declaring the distribution as income*. Under the Pension Protection Act (PPA) of 2006, which became permanent in December 2015, you may roll over up to \$100,000 in any one year from your IRA to certain funds at Central Kentucky Community Foundation without incurring any taxable income—a great tax savings opportunity!
